An installment payment plan is available, and must be requested within 60 days.

APPEAL YOUR PARKING CITATION

All appeals must be received within 21 calendar days of the issue date on the parking citation.

To appeal your citation, please follow the steps below:

- 1. Provide a written statement explaining the reason(s) for the appeal.
- 2. Mail the statement of appeal (from #1, above), a copy of your citation, and any evidence you wish to present to:

If the citation was related to disabled parking, a copy of your disabled placard or placard ID. While not required, you may wish to send your appeal via certified mail, so you can track the appeal's delivery.

- 3. The appeal process can take up to 90 days. Do not pay your citation while your appeal is under review. Late fees will not accrue during this timeframe.
- 4. You will receive a final determination in the mail.
