

**IN THE CITY COUNCIL OF THE CITY OF VALLEJO  
ORDINANCE NO. 1716 N.C. (2d)**

**AN ORDINANCE AMENDING SECTION 7.100.070 E OF THE VALLEJO  
MUNICIPAL CODE REGARDING AGE OF MEDICAL MARIJUANA DISPENSARY  
EMPLOYEES AND VOLUNTEERS**

**WHEREAS**, on July 28, 2015, the City Council adopted Ordinance No. 1715 N.C. (2d) adding Chapter 7.100 to the Vallejo Municipal Code pertaining to limited immunity for medical marijuana dispensaries and repealing Ordinance No. 1709 N.C. (2d).

**NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF VALLEJO DOES ORDAIN** as follows:

SECTION 1. Vallejo Municipal Code Chapter 7.100.070 E is hereby amended to read as follows:

E. No Member under age 18 shall be allowed on the property unless he or she is accompanied by his or her licensed attending physician, parent(s) or documented legal guardian, or is an emancipated minor as demonstrated by documentation.

SECTION 2. EFFECTIVE DATE AND PUBLICATION. This ordinance shall take effect thirty (30) days after adoption.
